## German Utility Model Manual

German Utility Models (Gebrauchsmuster) are easily filed online through the GlobalIPCo.com online filing system.

### Rights

A German Utility Model provides the same rights as a German patent for 10 years from the date of filing.

### PCT path or direct filing with priority claim

There are two paths for obtaining a German Utility Model:

A) National Phase of a PCT patent application:

A German Utility Model can be filed by entering the national phase of a PCT patent application within 31 months from the earliest priority date (or the PCT filing date, if no priority is claimed).

A German translation of the PCT patent specification and a German translation of any amendments under Art. 19 PCT or Art. 34 PCT is needed for filing the German Utility Model application. It is not possible to file the German translation after the 31 months time limit.

If the German Utility Model is filed before the PCT patent is published by WIPO, Forms PCT/RO/101 and PCT/RO/105 must be submitted on filing.

B) Convention Utility Model with priority claim:

Instead of taking the PCT route, a German Utility Model can also be filed directly, and may optionally claim priority from one or more patent applications or utility models filed during the previous 12 months. No extension of the 12 month period is permitted.

The German Utility Model specification (description, claims, figures) must be filed in German language together with a pdf copy of each priority application. All documents must be submitted together when filing the application.

### Summary: From filing to grant

During the filing process, the GlobalIPCo system prompts you for information and documents required.

German Utility Models processed by the GlobalIPCo system are filed by Prisma IP, a German patent law firm. All instructions for filing are reviewed by a German patent attorney prior to filing.

The system will email you a filing receipt on the same day the German Utility Model is filed. If the German Utility Model is the national phase of a PCT patent application, a separate notification with the German application number follows after 3-4 business days. If the German Utility Model is not the national phase of a PCT patent application, the German application number is directly assigned on the day of filing and emailed to you.

The German Patent and Trademark Office conducts only formal examination of German Utility Models, and the Utility Model is immediately granted after successful formal examination. German Utility Models are not subject to substantive examination.

The registration certificate (paper version) is usually issued 2-3 months after filing. A scan of the certificate is emailed to you. You may order postage of the original paper certificate.

The publication of the Utility Model takes place 6-8 weeks after registration, concluding the grant procedure.

To maintain the Utility Model, renewal fees are payable (discussed below).

## **Novelty and inventive step**

A German Utility Model is not subject to substantive examination regarding novelty and inventiveness. After mere formal examination, the German Utility Model is granted (registered), usually 2-3 months after filing and sometimes even within a few weeks. To be enforceable, the German Utility Model must nevertheless be novel and inventive over the prior art. Prior art includes:

- prior written disclosure anywhere in the world; and
- prior use within Germany.

Prior use of the invention outside Germany is not detrimental to novelty and inventive step. Furthermore, any disclosure or use by the applicant within 6 months before the time rank (i.e., filing date or priority date) of the German Utility Model does not form part of the prior art.

## **Priority**

A German Utility Model may claim priority from one or more patent applications or utility models filed during the previous 12 months. No extension is permitted.

**Required documents:**

- Where the German Utility Model is a PCT national phase application, no priority documents are required, provided that the priority documents were provided to WIPO.
- Where the German Utility Model is a convention application, a copy of the priority document (in pdf format) is required. Either the “as filed” application (preferably, with the filing receipt as page 1) or a certified copy of the priority document should be uploaded. The German Patent and Trademark Office does not accept published copies of the priority document.

For the validity of the priority claims, the content of the convention German Utility Model specification does not need to be strictly identical to the priority document. If content is added, the principle of partial priority applies: The priority claim is valid for the content of the German Utility Model that is also disclosed in the priority application, whereas added content not supported by the priority application does not enjoy the priority date but has the time rank of the filing date of the German Utility Model.

**Preparing application documents****General Requirements:**

- Description, claims and figures must be in German language.
- Margins: upper 2.5cm, left 2.5cm, right 1.5cm, bottom 1cm.
- Do not use line numbers.
- Do not use paragraph numbers in the description.
- Use only SI units.
- Do not refer to brand names / trademarks.
- Use typed text only (no handwritten text).

**Drawings:**

- Black & white or grayscale, no colour.
- Use reference numbers (referred to in description and claims).
- Drawing numbers and reference numbers must be at least 0.32cm high, i.e., at least as high as the text of the description and claims.
- No handwritten text.
- No text apart from figure and reference numbers.

**Claims:**

Allowed:

- multi-dependent claims;
- multiple independent claims (albeit that unity of invention is required); and
- reference numbers in claims.

The requirement of unity of invention is not very strict, compared with unity of invention requirements in other countries.

Method claims and plant / animal variety claims are not allowed. If the German Utility Model is the national phase of a PCT patent application that includes such claims, you need to file amended claims in which the method claims or plant / animal variety claims are deleted.

There is no limit on the number of claims. Costs are fixed, irrespective of the number of claims.

## **Amended application documents**

### **Where the Convention Utility Model is amended relative to the priority application:**

You may need to amend the German Utility Model specification relative to a priority application, in particular to delete method claims. To do so, simply upload the German version (description, claims, figures) in clean form as the application text. It is not necessary to submit a tracked version showing amended pages (showing changes made) .

### **Amendment upon national phase entry of PCT patent application:**

National phase German Utility Models may without additional cost be amended on filing, e.g. to remove method claims, to correct errors in the description and/or to delete figures. To do so, simply upload clean sheets of the amended documents. Do not upload a tracked versions of the amended claims (showing changes made).

If a claim is deleted, all subsequent claims must be renumbered. For example, if original claim 5 is deleted, original claim 6 must be renumbered to 5. The references to antecedent claims must also be adjusted accordingly.

New claims may be added, if they are supported by the original PCT description/claims (i.e. subject to fair basis).

It is not allowed to add new matter that was not disclosed in the original PCT patent application. For example, it is not allowed to add new figures. However, you can correct a figure, e.g., to correct reference numbers.

In addition to the amended German document in clean form, you need to upload a German translation of the original (unamended) PCT patent specification.

## **Change of Applicants**

You can easily change the applicant(s) for the German Utility Model from the applicant(s) of the priority application or the PCT patent application. Simply enter all (i.e. new and old) applicant names and addresses, as shown below in the section “How

to file a national phase German Utility Model” and the section “How to file a direct / convention German Utility Model”. Convention German Utility Model applicants may be changed (when compared to the applicants on the priority document) on filing to add applicant(s) at no additional cost or to remove applicant(s) for \$80.

No signed documents or other proof (e.g. deeds of assignment) need to be uploaded. However, it is advisable that proof of any assignments is kept by the applicant.

The cost to record an assignment of a national phase German Utility Model is US\$80, if made on filing the German Utility Model. The cost is directly applied by the GlobalIPCo.com online filing system.

For national phase German Utility Models, no information of the priority applicants is required. If the national phase German Utility Model applicants are the same as the PCT applicants, no additional charges apply, regardless whether any priority applicants differ from the PCT applicants.

Changes to applicants’ names or addresses may also be made after filing and after grant at additional cost.

**Notes:**

- The German Patent and Trademark Office automatically re-orders applicants (typically alphabetically) on filing, ignoring the order in which applicants are listed on the GlobalIPCo.com online filing system.
- The German Utility Model registration certificate does not display the entire address of the applicants. Only the applicant’s name, city and country is displayed.
- The applicant’s address must be a residential address (not a work address).

## **Delay of grant and publication**

Grant and publication of national phase German Utility Models cannot be delayed. However, a request to delay grant and publication of convention / direct German Utility Models by up to 15 months is possible.

If you wish the grant and publication to be delayed, please indicate the number of months for the delay on the GlobalIPCo.com online filing system. An additional charge of US\$50 is automatically applied.

## **Sequence listing**

The GlobalIPCo system does not provide for lodging of sequence listings.



## Review on filing

Prisma IP will conduct a cursory review of all German Utility Models prior to filing. During such cursory review, Prisma IP may (without notice to you) make non-substantial changes to your German Utility Model application and such other changes required to comply with DPMA rules prior to filing. Despite such review, neither GlobalIPCo nor Prisma IP guarantees that no office action will be issued by the German Patent and Trademark Office in respect of German Utility Models filed using the GlobalIPCo system.

## Office actions

If formal defects in your German Utility Model results in the German Patent and Trademark Office issuing an office action, you will be notified of the office action and requested to submit substitute documents for filing. The fixed cost to respond to an office action is \$200.

## GlobalIPCo Pricing

A change of the national phase German Utility Model applicant relative to the PCT applicant or priority applicant costs US\$80, if made on filing of the German Utility Model. And, a response to an office action is fixed at \$200.

Pricing is fixed, irrespective of the number of priority claims, claims, pages, etc.

**Note:** Postage of the German Utility Model certificate is optional. Upon receipt of the certificate, a scanned copy will be emailed to you without charge.

## Renewal

A German Utility Model must be renewed on the 3<sup>rd</sup>, 6<sup>th</sup> and 8<sup>th</sup> anniversary of the (earlier of) the PCT filing date / German Utility Model filing date to maintain the German Utility Model in force for a period of 10 years.

## How to file a national phase German Utility Model

1. Register on GlobalIPCo.com (there is no subscription / license fee. You are only charged for actions instructed);
2. Receive a discount code that reduces pricing for law firms and add this to your profile; and
3. Complete the national phase German Utility Model application form shown below.

### Requirements for completing the national phase German Utility Model application:

- German translations:
  - German translations of original PCT Claims, Description and Figures (pdf files);
  - German translation of Article 19 and/or Article 34 PCT claims and/or description pages, in clean version without marked amendments (if any);
  - Title of the invention (in German);
- Basic information on the PCT patent application, namely:
  - PCT application number and PCT filing date;
  - Applicant's name (as recorded at WIPO) and physical address;
  - Number of Claims of the original PCT specification (irrespective of multi-dependencies);
  - Number of Figures of the original PCT specification;
  - Earliest priority date (if any).

Not required for a national phase Utility Model application is a German translation of the abstract, the inventor data, a signed power of attorney, copies of priority documents or translations of priority documents.

No German abstract is needed.

If the German Utility Model is filed before the PCT patent is published by WIPO, Forms PCT/RO/101 and PCT/RO/105 should also be uploaded. Should the Form PCT/RO/101, Form PCT/RO/105 or the original PCT specification not be available, we may still file the application but the German Patent and Trademark Office will only be able to process the application and issue the German Utility Model application number with a delay of a few months.

If you wish only to amend the claims but not the description and figures, only upload “Amended claims for on-filing amendment” and do not upload any files for “Amended description for on-filing amendment” or “Amended drawings for on-filing amendment”.

Amendments (claims, description and/or figures) must be submitted in clean form, without tracked changes.

The amended documents must be complete: For example, if only a sentence on description page 1 is changed, you must still upload all description pages as “Amended description for on-filing”.

If the PCT application includes method claims, you must file a German claim set without the method claims as “Amended claims for on-filing amendment”.

If the applicants of the German Utility Model are different to the applicants of the priority application, select:
