## South African Trademark Manual

South African trademarks are easily filed online through the GlobalIPCo.com online filing system.

### **Rights**

A South African trademark registration prevents others from using a brand name / logo / slogan which is the same as, or confusingly similar to your trademark registration in South Africa.

#### Search

The GlobalIPCo system (<u>https://globalipco.com/how-to-za-trademark/</u>) provides an online facility for conducting free identical South African trademark searches:

**Note:** The GlobalIPCo trademark search facility does not include trademarks filed within the last 6 weeks. If a confusingly similar trademark has previously been filed, or if a similar unregistered trademark already enjoys a reputation in South Africa, the South African Trademarks Office may refuse an application.

Alternatively, instruct our South African agent (S&Z) to conduct a professional trademark registrability search for \$300.

# Filing a South African trademark through GlobalIPCo

- 1. Register on GlobalIPCo.com (there is no subscription / license fee. You are only charged for actions instructed);
- 2. Receive a discount code that reduces pricing for law firms and add this to your profile; and
- 3. Complete the South African trademark application form:

## Mark / Logo page

- Your reference: This is the reference used within your business to identify the trademark application.
- Type of mark:

Word mark

- Word mark: Type the word/s of the trademark, e.g. GLOBAL IP CO.
- **Case sensitive:** If the case (i.e. upper / lower-case) of the characters is important, select "Yes" and the case will be preserved. Alternatively, the case will be ignored and the trademark will be filed with capital letters, meaning protection will be granted irrespective of the case (*recommended*).

## • Endorsements:

#### Transliteration:

If the mark includes non-Latin characters, for example "Technik school 北京", rewrite the entire mark in Latin characters, i.e. "Technik school **Beijing**"

Endorsement that will be submitted: *The transliteration of the mark is "Technik school Beijing"*.

**Note:** Transliteration is a conversion of text from one alphabet (e.g. Chinese characters) to another alphabet (e.g. Latin / Roman alphabet). Translation is the conversion of a word in a foreign language (e.g. Chinese pinyin) into English where both words are in the same alphabet.

#### Translation / No meaning statement:

If the mark has non-English words, indicate whether the non-English words have meaning in English. If yes, provide the English translation of the entire mark. For example, "**Technik** school 北京" should be translated to "**Technology** school **Beijing**".

Endorsement that will be submitted: *The translation of the mark is "Technology school Beijing".* 

Disclaimers:

Disclaim words that are commonly used in the trade associated with the class(es) in which the mark is to be filed. For example, for the mark "Irresistible **Fruit**" in class 29, consider disclaiming "**fruit**".

Endorsement that will be submitted: *Registration of this trademark shall grant no right to the exclusive use of "fruit" separately and apart from the mark.*

• **Select class(es):** South Africa does not permit multi-class trademarks. A separate South African trademark will be filed for each class selected.

Trademark protection is limited to the goods/services within the selected class/es. If the incorrect class is selected, the trademark may not be enforced.

South Africa uses the 12th Edition (12-2024), of the Nice Classification of Goods and Services (<u>https://www.wipo.int/classifications/nice/nclpub/en/fr/</u>).

The description of Goods / Services within a class may be edited. However, applicants generally select all Goods / Services within a class.

# Process

The South African trademarks office examines trademarks to ensure that they meet the formal and substantive requirements.

# **Timelines:**

Examination:	within 9-12 months of filing
Acceptance:	within 3-6 months of responding to routine office action
	(if necessary)
Publication:	within 1 month of acceptance. Trademarks are open to opposition for 3 months, calculated from the publication date
Issuance of certificate:	within 4 months of expiry of the opposition term. Certificates are issued in electronic format only

### Renewal

A South African trademark must be renewed on the tenth anniversary of the filing date and every ten years thereafter.

#### Late-payment:

Renewals may be paid during the 6 month grace period on payment of a penalty (R48). The PayAnnuity renewal system charges: (i) the manual renewal fee (which is higher than the online renewal fee); and (ii) \$25 in professional fees for paying the late payment penalty.
